The cultural heritage of the forests and in the forests tackles the multiple interrelationships between forests, forest management and the human society, which have changed in the course of history. It is not only confined to demonstrating historical developments, but contributes also considerably to a better understanding of the present situation of forests and the development of the cultural landscape, and provides valuable input for forest conservation and management policies. The EU-Action Plan 2006 acknowledged cultural landscapes, traditional practise and other cultural values of forests as some of the ways of achieving local and regional sustainable development. Landscape values are also included in the new Common Agricultural Policy (CAP) and the European Landscape Convention. Cultural landscapes are considered to be a development factor. These potentials have only partly been investigated till now. However, there is an increasing demand by forest owners related to new markets and additional income beside forestry and an increasing interest of tourisms in the utilization of forest areas and beautiful sceneries. At present numerous initiatives, collections and museums exist; however, they are often not adequately linked. We are living in a time of increasing dependence on and encounters with synthetic materials, such as plastics, in our day-to-day life.

The Plastics Heritage Congress 2019, whose general theme is « *Plastics heritage: history, limits and possibilities*" intends to emphasize the synthetic material's « plasticity » that makes them crucial in today's globalized world and to understand the chameleon capability of plastics, their limits and possibilities.

This congress aims to address plastics history and heritage by encouraging papers that contribute to a deeper understanding of the socioeconomic culture and material culture of historic polymeric materials (HIPOMS) in their various representations and functions in society.

The main theme embraces the concepts of history, limits and possibilities of plastics heritage as organizing principles, thus perceiving their impact on the consumer and their technical and scientific developments. The programme committee suggests the following non-exhaustive sub-themes for contributors of individual papers, and posters:

- Plastics history (historic polymeric materials [*Hipoms*] manufacturing, engineering, companies)
- Plastics heritage (*Hipoms* in art, design, everyday use, technical objects and architecture)
- Collecting *Hipom* objects

Special Journal Issues

A number of selected high-impact full text papers will also be considered for the special journal issues. All submitted papers will have the opportunity to be considered for this Special Journal Issue. The paper selection will be carried out during the peer review process as well as at the conference presentation stage. Submitted papers must not be under consideration by any other journal or publication. The final decision for paper selection will be made based on peer review reports by the Guest Editors and the Editor-in-Chief jointly. Selected full-text papers will be published online free of charge.

Deadline for submission: 31 October 2018

Who can apply?

All <u>States Parties to the World Heritage Convention</u> are eligible in principle. Individuals, foundations, IGOs and NGOs **are not** eligible for submitting International Assistance requests under the World Heritage Fund.

International Assistance requests must be transmitted by a State Party National Commission for UNESCO or Permanent Delegation to UNESCO, or an appropriate governmental Department or Ministry. Individuals who do not represent one of these bodies are not entitled to submit requests for International Assistance.

States Parties in **arrears** of payment of their compulsory or voluntary contributions to the World Heritage Fund are **not eligible** for International Assistance. For example, for the 2017 cycle, it means that all contributions up to 2016 included have to be paid. The status of contributions can be checked on whc.unesco.org/en/world-heritage-fund

Moreover, the *Operational Guidelines* outline that when funds available are limited and a selection has to be made, preference should be given to:

- A Least Developed Country (LDC) or Low Income Economy (LIE) as defined by the United Nations Economic and Social Council's Committee for Development Policy, or
- A Lower Middle Income Country (LMIC) as defined by the World Bank, or
- A Small Island Developing State (SIDS), or a State Party in a post-conflict situation.

How to apply?

International Assistance requests must be transmitted by a State Party National Commission for UNESCO or Permanent Delegation to UNESCO, or an appropriate governmental Department or Ministry. Individuals who do not represent one of these bodies are therefore not entitled to submit requests for International Assistance. Applications can either be made online of offline.

The deadline to submit an application for funding in 2019 is **31 October 2018**.
