



What is the difference between the two? The conference aims to examine the ways space is bounded or expanded to create place. We will begin to map how the concepts and experiences that make up our understanding of what spaces and places mean are political, social, and specific to our culture(s), and how space and place dance with each other in the middle of it all. Our discussions and reflections will take place with a view to forming an innovative publication to open the doors to engender further collaborations, research and discussions.

Rather than focus on a specific space or place – though case studies and problem solving exercises are illuminating ways of drawing perspectives and insights we invite proposals that cover a number of approaches to the way processes of all kinds shape us and our world in the way they create, confine, shape and define the spaces and places we inhabit.

300 word proposals, presentations, abstracts and other forms of contribution and participation should be submitted by Friday 9th November 2018. Other forms of participation should be discussed in advance with the Organising Chair.

All submissions will be minimally double reviewed, under anonymous (blind) conditions, by a global panel drawn from members of the Project Development Team and the Advisory Board. In practice our procedures usually entail that by the time a proposal is accepted, it will have been triple and quadruple reviewed.

You will be notified of the panel's decision by Friday 23rd November 2018.

If your submission is accepted for the conference, a full draft of your contribution should be submitted by Friday 1st March 2019.

#### **Conference on African Studies: Recovering,** digitizing and practicalizing Africa's Indigenous Knowledge

July 15, 2019 , Kenya Closing date: December 1, 2018

Following broadly defined and multi-purpose transdisciplinary approaches to areal studies, the African Studies Research Center, Kisii is holding its first international conference focusing on four largely circumscribed thematic research areas under the theme of "Recovering, digitizing and practicalizing Africa Indigenous Knowledge". The goal in accordance with the objective of the emerging African Studies Research Center at Kisii University is to provide, fieldwork-based documentation of those traditional ways of knowing and doing things across nations of Africa spanning different institutions as well as give theoretical account of the same. The intent is to bring together scholars and practitioners alike to make sense of indigenous ways of knowing and of doing things across the continent, and to analyze persistent issues in a way that would liaise with science to proffer viable solutions that in turn would inform practice. Essentially, the conference is to transition us from Knowledge to practical applications.

The ways of life on the continent are not static, the various cultures of African peoples continue resiliently in responding to those persistent questions of life and newer ones. It therefore does become necessary to harness the information that generations have produced over the lifespan of a community and on which they have relied to sustain their people and meet their needs.

We invite submission of abstract for impactful and action-oriented oral and poster conversations that would lead to building a functional bridge that links the past with the future, that connects the traditional to the global, and that affords the transitioning of the analogue to the digital. We would like to explore ways to harness and conserve existing information for the creation of new solutions while assuring the integrity of the underlying socio-cultural heritages.

general scope of the conference widely themed as: The American Civil War may have ended in 1865, but in African many respects it is still being fought today, over 150 years later. Ongoing battles over the Confederate flag and the recent Confederate monument controversy Cultural, Indigenous and Heritage Studies [Arts, suggest that many of the wounds of the war, especially those related to race, class and gender, are still far from Political and Economic Studies [Political, economic being healed. Clearly, what led to the Civil War is still dividing the nation: Americans are not only grappling with a future vision for the country, but are also struggling with the past. What are considered by some to be markers of cultural heritage are for many others painful symbols of the violent history of the United States, a nation that was built on the exploitation of African Americans, Native Americans, Asian Americans countless meanings and manifestations.

> If "we are what we remember" then who are Americans exactly? Is what we remember just as important as how we remember it? American identity is closely invested in commemoration; national holidays, for example, construct a common past in a country of immigrants without a common past. They help make sense out of distant events, reinforce collective "values" in the present, and theoretically map out a shared future. Yet, those aspects of "history" that are (or are not) chosen for display in a museum, preservation in an archive, depiction in a work of art, or narration in a work of literature also speak volumes about a nation and its competing, and often contradictory, histories, and that the past is truly never dead.
